# Why?

Our research theme of changing forest ownership is very diverse and context specific. It is a complex problem.

## To tackle complex problems:

- understanding local contexts
- building a shared understanding of the issues
- linking experiences in successive meetings
- reflecting

## Fortmann & Ballard (2011)

When scientists do research in collaboration with local experts the resulting knowledge can be more accurate and more policy relevant than they could produce doing research on their own or only with other conventional scientists".

# The TRAVELLAB

- = joint learning processes from facilitated stakeholder interactions, and iterative reflection and learning cycles
- = '**lab**' because it is about learning
- = 'travellab' because it is about learning while we travel to visit each other's realities

It is one research strand in our COST Action.

## Questions (examples WG1, Solsona)

- Q1: (**Types of Ownership**) What do you consider a traditional forest owner?/And what do you consider a non-traditional forest owner?
- Q2: (**Challenges, Problems**) In your opinion, what are the biggest challenges that /you as a forest owner/ forest owners in your region face?
- Q3: (**Chances?**) Are you happy with how the forest in this region/your forest is managed?- did not work: What do you think of the current forest management in this region?
- Q4: (Future) Who do you see owning your land in the future? And how will it be managed?




